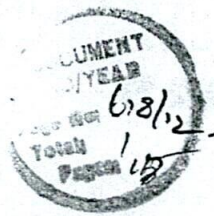

THIS DEED OF DECLARATION OF TRUST is made on this, the 2nd day of April, 2012 by Dr. B. BABU MANOHARAN, son of late Mr. A.P. Balraj, aged about 54 years having income-tax PA No. AAHPM9218P, residing at No. 56-C, Old Mahabalipuram Road, Sholinganallur, Chennai 600 119, hereinafter called the **FOUNDER / AUTHOR** of the Trust.

The Author / Founder is desirous of establishing an irrevocable Public Charitable Educational Trust for the purpose of running educational institutions of higher order with national international standards for the benefit of the community at large, belonging to the educationally, socially and economically backward communities, without any distinction based on caste, religion or sex particularly.

The Founder is a Christian by religion. The founder makes it clear that only his family members as detailed hereunder shall be the trustees and the entire family is following Christian religion. The co-option of any other trustee shall be only from the Christian community solely at the discretion of the members of the founder's family as detailed hereunder after the life time of the Founder.

WHEREAS the founder of the trust has decided to endow a sum of Rs. 1001/- (Rupees one thousand and one only) in this behalf which has been handed over to the trustees to hold the same upon trust together with all the income arising there-from and all the accumulations and accretions thereto, including corpus donations, for the intent, purpose and objects herein contained.

AND WHEREAS it is considered necessary and expedient that the objects of the Trust should be reduced into writing.

NOW THIS DEED WITNESSETH AS FOLLOWS:

1. It is hereby declared that the trustees hereinafter shall stand possessed upon trust for the objects set out here-under a sum of Rs. 1001/- (Rupees one thousand and one only) given by the Author and Founder, the receipt of which sum the trustees admit and acknowledge, and all other property that may from time to time be bequeathed, devised, donated, gifted, or otherwise assured such manner of the Trust hereof, the property from time to time representing the same and the income thereof and the money arising therefrom subject to the powers and provisions detailed hereunder.

The Trust shall be called **ST. JOSEPH'S EDUCATIONAL TRUST** AND SHALL BE CONSTITUTED FOR THE PURPOSE, AIMS AND OBJECTS HEREINAFTER MENTIONED. The office of the Trust shall be at No.56-C, Old Mahabalipuram Road, Sholinganallur, Chennai 600 119.

2. THE OBJECTS OF THE TRUST SHALL BE THE FOLLOWING:

- (a) To establish, acquire, maintain, run, improve and develop educational institutions like schools, colleges, poly-technics, medical, dental and engineering colleges, business schools, management and computer education, hotel management, nursing, teacher education and universities declared under section 3 of the U.G.C. Act including hostels without any motive of profit.
- (b) To seek and get affiliation of the various institutions run by the Trust and private Universities to be formed in due course under section 3 of the U.G.C. Act of different disciplines.
- (c) To seek and get approvals from the Government bodies such as AICTE, Medical Council of India, Dental Council of India, U.G.C. NCTE, and affiliation from the respective other statutory universities affiliating technical courses as well as general academic courses and any other authorities at present in existence or to be established by the State / Union government from time to time.
- (d) To award scholarships, prizes, etc., for the poor and deserving meritorious students.
- (e) To establish, maintain, run, improve and develop libraries, reading rooms, and other facilities for the benefit of the students.
- (f) To publish books, periodicals and other works without any motive for profit.
- (g) To give donation and to take over, maintain, run and improve the educational institution / institutions having similar objects.
- (h) To accept donations, gifts, presents, aid, grants, in cash or in kind and movable or immovable properties from the public, Union / State governments either as corpus or as in cash according to the directions of the donors for the purpose of carrying out the objects of the Trust.
- (i) To do all such lawful acts that may be necessary or incidental and conducive to the attainment of the above objects or any one of them.
- (j) To undertake such other activities as may be necessary for the promotion of the objectives of the Trust.

3. BOARD OF TRUSTEES

(I) The first **BOARD OF TRUSTEES** shall consist of the following persons :

- 1) **Dr. B. BABU MANOHARAN**, the Author and Founder of the Trust, aged about 54 years, son of late Mr. A.P. Balraj, residing at No. 56-C, Old Mahabalipuram Road, Sholinganallur, Chennai 600 119.
- 2) **Ms. JESSIE PRIYA**, daughter of Dr. Babu Manoharan, aged about 21 years, residing at No. 56-C, Old Mahabalipuram Road, Sholinganallur, Chennai 600 119.
- 3) **Dr. JEPPIAAR**, son of late Mr. Jesu Adimai, aged about 73 years, residing at No. 56-C, Old Mahabalipuram Road, Sholinganallur, Chennai 600 119.
- 4) **Mrs. REMIBAI JEPPIAAR**, wife of Dr. Jeppiaar, aged about 63 years, residing at No. 56-C, Old Mahabalipuram Road, Sholinganallur, Chennai 600 119.

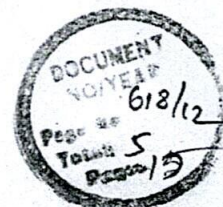
Dr. B.BABU MANOHARAN shall be the first Managing Trustee of the Trust and shall hold the office of the Managing Trustee for his life or until he resigns.

(II) The aforesaid Managing Trustee may, at any time and from time to time, fix or vary the number of trustees, appoint new or additional trustees. The Managing Trustee has full power to appoint any person from among their family members as trustee of this Trust but such person shall belong to the Christian community.

(III) The Founder hereby affirms that the first trustees of the Trust shall be the four persons hereinabove referred to as the trustees including the Founder.

(IV) All the trustees for the time being and from time to time in office, shall be referred to collectively as Board of Trustees.

(V) Dr. B. BABU MANOHARAN and Ms. JESSIE PRIYA shall hold office of this Trust for their life time or until they resign.

(VI) The strength of the trustees at any point of time shall not be less than two or more than six.

(VII) A trustee shall cease to be a trustee if a resolution to this effect is passed by a majority of trustees at a meeting.

(VIII) It shall be open to any one of the trustees to retire from the office of the trustees by giving one month's notice to the trustees of their intention to retire.

4. PROCEEDINGS OF THE TRUST

- 1) The trustees shall meet regularly
- 2) The trustees may meet for dispatching of day to day work, adjourning or otherwise regulating their proceedings as they may deem from time to time.
- 3) The Managing Trustee of the Trust shall preside over all the meetings of the Trust during the term of his office and if he is unable to attend the meeting the Managing Trustee shall appoint one among the others as Chairman of the meeting.
- 4) A resolution in writing signed by a majority of the trustees shall be valid and effectual as if it has been passed at the meeting of the trustees duly called and constituted.
- 5) The quorum of holding the trustees meeting shall be two out of which one should be the Managing Trustee.
- 6) The decision of the majority of the trustees shall be considered valid and must also be carried out accordingly.

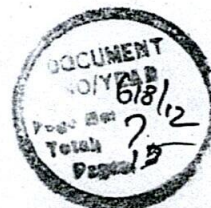
5. POWERS AND DUTIES OF THE MANAGING TRUSTEE

The Managing Trustee is empowered to do all and such things as may be necessary, incidental, conducive or convenient to the attainment of the objectives of the Trust or any of them.

Without prejudice to the generality of foregoing, the Managing Trustee shall have the following powers:

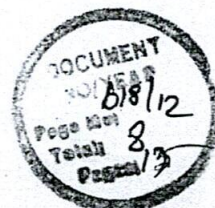
1. To delegate any power as he can lawfully delegate to any person and to execute such power of attorney as he may think fit for the purpose.
2. To withdraw any power or revoke any appointment of any employee or attorney.
3. To buy or take on lease, immovable property for the Trust and to put up buildings or structures on land belonging to or under the control and possession of the Trust.
4. In the professed execution of the Trust and powers hereto no trustee shall be liable for any loss to the Trust properties arising by reason of any investments made in good faith except willful or deliberate fraud or wrong-doing on the part of the Trustee who may be subjected to be made liable.
5. To sell, give on lease or license, mortgage, pledge, charge, surrender, pledge, hypothecate, transfer, deal with or dispose of all or any properties, funds or assets of the Trust, movable or immovable and to reinvest the proceeds in such other form of investment as would, in the opinion of the Trustees, be beneficial to the Trust.

6. To sub-lease or let out any portion of the immovable property in possession or under the control of the Trust at such rent and for such periods and on such terms and conditions as they may think fit, and to apply the income derived therefrom for the objects of the Trust.
7. To open, maintain, or operate bank accounts in the name of the Trust and such bank account shall be operated only by the Managing Trustee.
8. To invest and deal with the funds of the Trust in such manner as may, from time to time, be deemed as expedient in accordance with the provisions of the Income-tax Act, 1961 and the Indian Trust Act, 1882 as amended from time to time and the Rules framed thereunder, as may be in force from time to time, and to redeem, reinvest and vary such investments from time to time as may be deemed fit. Without prejudice to the generality of the foregoing, to invest in RBI Bonds, Post Office Savings Certificates and mutual funds as may be approved under the Income-tax Act, 1961 and the Indian Trust Act, 1882 and redeem, invest or vary the same.
9. The Managing Trustee shall have every power for the purpose of managing, conducting and administering the affairs of the educational institutions, hostels, medical institutions, universities and other establishments conducted by the Trust.
10. The Managing Trustee shall arrange for the maintenance of correct and proper accounts of the receipts and disbursements and of the liabilities incurred and of the assets acquired and for an audit every year of the accounts of the Trust and of the income and expenditure relating thereto and for this purpose the Managing Trustee shall appoint in consultation with the Board, an independent auditor or auditors.

11. The Managing Trustee shall have power to purchase, from time to time, such materials and things as may be necessary for the said educational institutions, universities and other establishments.
12. The Managing Trustee may, if and when he desires delegate for a temporary period his authority in respect of the administration of the institutions to one of the trustees.
13. The Managing Trustee shall be the executive officer of the Board and as such he shall have power and authority for and on behalf of the Board.

To carry out the resolutions of the Board.

To sign papers, receipts and documents.

To pay money due by the Trust and demand and get receipts therefor.

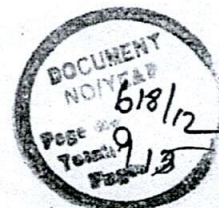
To demand and receive money due to the Trust and issue receipts for the money so received.

To open current and deposit accounts in the name of the Trust with such bank or banks as the Board may from time to time authorize in this behalf to deposit the funds of the Trust in such accounts on behalf of the Trust.

To make, draw, endorse, accept, sign, negotiate or transfer, cheques, promissory notes, hundies, bills of exchange, bills of lading, railway receipts, warrants and other negotiable or transferable instruments, government securities or other securities.

To lease out for a period not exceeding three years at a time, lands and properties of the Trust which are ordinarily leased out.

To initiate, prosecute, defend, compromise to arbitrate or abandon, legal proceedings or dispute and to sign all papers in connection therewith.

To appoint, employ, remunerate, remove, suspend, discharge, dismiss, reemploy, replace, transfer and accept resignation of staff and workers permanently, temporarily or otherwise.

To remove any Trustee or Trustees from Trust and appoint any new Trustee or Trustees in the place of them.

To call for the meeting or meetings of the Board, and

To execute all documents on behalf of the Board.

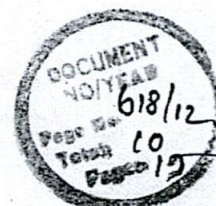
14. No act of the Managing Trustee requiring the previous sanction of the Board shall be invalid merely by reason of the absence of such previous sanction, if the said act is subsequently ratified by the Board.

15. The Managing Trustee and other trustees may reimburse themselves out of the Trust money in their hands all expenses properly incurred by them in or about the execution of the objects of the Trust and in discharge of the duties imposed on them under this Trust.

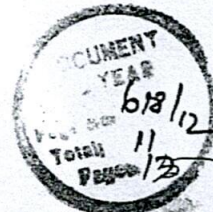

16. There shall be an annual meeting of the Board not later than 31st July when the annual audited statements of accounts shall be considered and adopted. The Managing Trustee shall, at such meeting place before the Board, a report of the working of the several institutions operated and maintained by the Trust. The Managing Trustee shall give atleast 14 days written notice of the meeting to the Trustees specifying the day, date, place, time and agenda, of the meeting. Along with the notice the Managing Trustee shall also send to every one of the Trustees a copy of the audited statement of accounts intended to be placed before the meeting.
17. The Board shall consider at the said meeting the report of the Managing Trustee and that of the auditor and the audited accounts and if the Board proceeds to approve and adopt them, such approval and adoption shall be by means of a resolution to that effect. The Board shall also transact such other business at that meeting about which due notice had been given as aforesaid. All the proceedings and resolutions passed by the Board shall be recorded in a separate Minutes book. In the absence of the Managing Trustee any one of the Trustees may be nominated by the Managing Trustee to preside over the Meeting.
18. Any two trustees, including the Managing Trustee of the Trust may call a meeting of the Board for the consideration of any specific subject or subjects to be mentioned by the trustees convening the meeting of the Board. There will be a notice of atleast 14 days for every meeting so convened. The posting of a prepaid letter to the proper last known address of a trustee containing date, day, time, place and the agenda of the meeting shall be deemed to be a proper notice of the meeting and such shall be deemed to have been served on the day on which the letters so posted should normally reach the address in the usual course of the post. A notice may also be served on a trustee in person.

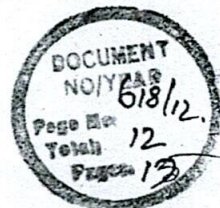

19. The business of the Board shall be transacted either at the meetings of the Board or by resolutions passed in circulation. The resolutions to be passed in circulation shall be sent to all the trustees and the resolutions so circulated shall be deemed to have been passed only when a majority of the trustees as per the quorum signify their consent in writing.
20. In all matters pertaining to the Trust, the decision of the majority of the trustees as per the quorum present at a meeting of the Board shall be the decision of the Board and shall be binding on all the trustees of the Board.
21. In the event of the votes being equally divided, the Managing Trustee shall have a casting vote in addition to his / her vote as a trustee of the Board.
22. No act or resolution of the Board shall be invalid merely by reason of there being one or more vacancies on the Board. But no act or resolution of the Board other than act or resolution approving or electing a trustee shall be valid if the strength of the Board at any time is less than two.
23. No act or proceedings of the Board or of the Managing trustee or of any trustee shall be deemed to be invalid by reason only of any defect in the appointment or the constitution of the Board or of any member thereof or on the ground that any member of the Board was not entitled to hold or to continue in office by reason of any disqualification or by reason of such act having been done or proceeding taken during the period of any vacancy in the office of the Managing trustee or of any other trustee.

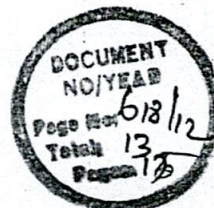
6. ACCOUNTS

- 1) The Managing Trustee shall have the custody and control of all the documents of title to the properties of the Trust and all other documents, accounts and other papers relating to the Trust and the same are open to inspection by any Trustee on reasonable notice during office hours of the Trust office.
- 2) The Managing trustee shall on request by any trustee, furnish such information as the latter may reasonably require in respect of any matter pertaining to the Trust.
- 3) The Managing Trustee shall, once in every year, not later than the 31st day of July place before the Board for the consideration of and adoption by the Board, the Income and expenditure Account for the year ending on the previous 31st day of March and the balance sheet as at that date with the Auditor's report and certificate thereon. The Managing Trustee shall give to the Board such information and explanations as the Board may require for proper understanding of the accounts and statements placed before it.

7. GENERAL

- 1) The Trust shall conform to the provisions of the Indian Trusts Act, 1882 in all matters not expressly provided for herein but in case any difficulty or doubt arising on any question in respect of the management or administration of the Trust or any matters falling hereunder arises, the Managing Trustee may on behalf of the Board, apply to the Court for opinion, advice, direction and the trustees acting upon the direction, if any of the Court, shall be deemed so far as regards their responsibility to have discharged their duties in respect thereof.
- 2) The Board is hereby authorized to and it may from time to time make and prescribe rules, regulations and bye-laws regulating carrying out of the objects of the Trust, including the prospectus and application form for admissions, the code of conduct for the staff, students and employees, the method of recruitment of staff and employees, the payment of salary and other benefits and the procedure for taking disciplinary action against them.



- 3) The properties and funds belonging to the Trust shall be utilized for such other allied purposes as the Board may determine.
- 4) In the event of the Trust not being able to function in fulfillment of its object, the trustees shall after discharging all liabilities, transfer the assets of the Trust to any other public charitable institution or institutions having similar objects.
- 5) It is hereby expressly declared that this Trust is a public charitable Trust and the Trust hereby created is irrevocable.
- 6) It is hereby expressly declared that the activities of the Trust in accordance with the objects of the Trust shall be carried out only in India.
- 7) In the event of any dispute or difficulty against which no provision has been made in the Trust document or any doubt in the interpretation of any of the clauses supra, the High Court, Madras on its original side shall be the Court having jurisdiction and the parties can resolve the dispute through the said Court.



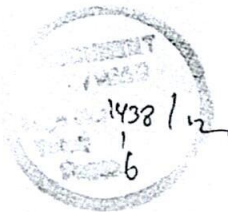

SUPPLEMENTARY TRUST DEED

THIS SUPPLEMENTARY TRUST DEED is executed at Chennai on this the 26 day of 09.2012 by Dr. B. Babu Manoharan, son of late Mr. A.P. Baulraj, aged about 54 years, having income-tax PAN AAHPM9218P, residing at No. 56-C, Old Mahabalipuram Road, Sholinganallur, Chennai 600 119, hereinafter called the AUTHOR / FOUNDER OF THE TRUST.

WHEREAS by a deed dated 2nd April 2012, executed by the Author / Founder, a Trust by name St. Josephs Educational Trust has been established by the Author / Founder;

WHEREAS the Trust has applied for registration under section 12AA of the Income-tax Act, 1961, to the Director of Income-tax (Exemptions), Chennai,



WHEREAS it has been found necessary to provide certain additional clauses to the said trust deed dated 02-4-02012 to satisfy the statutory provisions of the Income-tax Act, 1961 concerning charitable institutions,

THIS SUPPLEMENTARY TRUST DEED WITNESSETH as follows:

After sub-clause (7) of Clause 7 (GENERAL) of the Deed of Trust dated 2-4-2012, the following sub-clauses shall be inserted.

- "(8) In the event of winding up / dissolution of the Trust, the net funds would be transferred to institutions having similar objects and enjoying exemption under section 11 and 80G of the I.T. Act.
- (9) The activities of the Trust shall be purely charitable in nature and not motivated for profit.
- (10) The funds of the institution shall be utilized only towards its objects and no portion of it would be distributed in any manner to the trustees or persons defined in section 13 (1) (c) of the Income-tax Act, 1961.
- (11) The benefits of the objects shall be available to the general public irrespective of caste, creed, religion or sex".

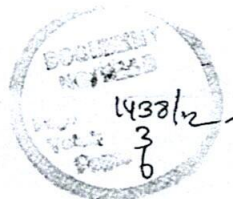

Dr.B. BABU MANOHARAN, son of Late A.P. Baulraj, aged about 63 years, having Income Tax P.A.No.AANPM9218P, residing at No.56C, Old Mahabalipuram Road, Sholinganallur, Chennai-600 119, **FOUNDER/AUTHOR OF THE TRUST.**
